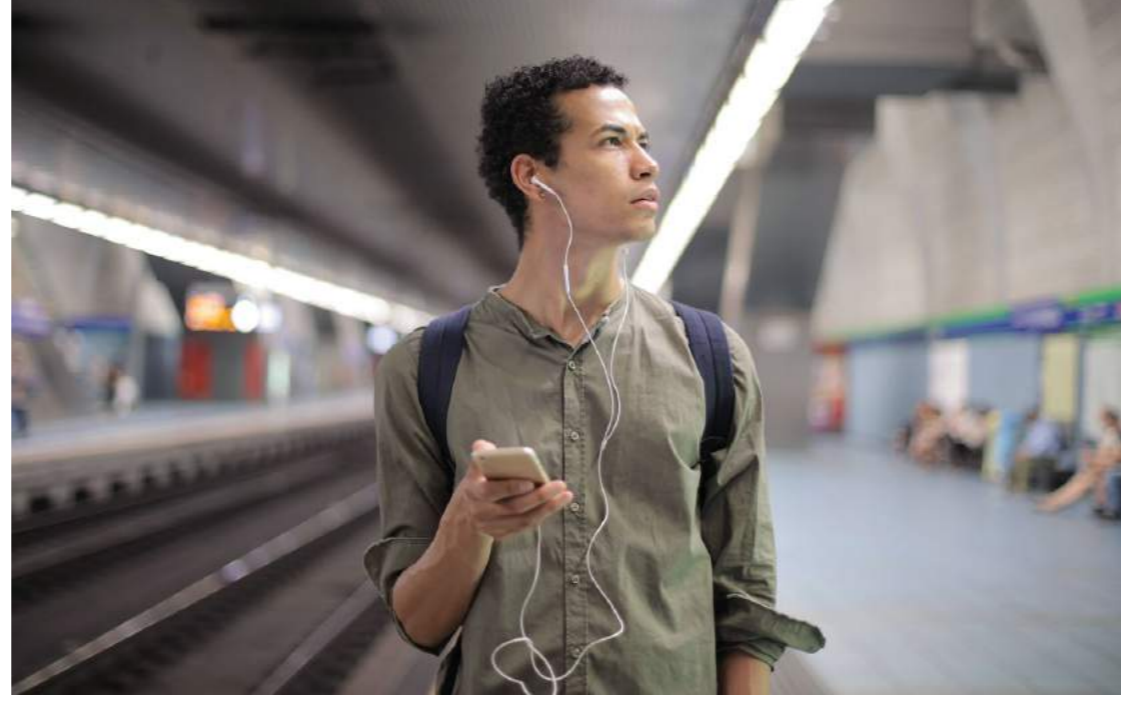

New updates coming in as revised guidelines for international arrivals has been released on 28th November 21 by the Ministry Of Health & Family Welfare, Govt Of India. This document provides protocols to be complied with international travelers as well those to be followed by airlines, points of entry (airports, seaports and land border) for risk profiling of passengers. The SOP will be valid w.e.f 1st December 2021 till further notice. The report has clearly mentioned the planning steps of travel and activities before boarding, during travel and on arrival.

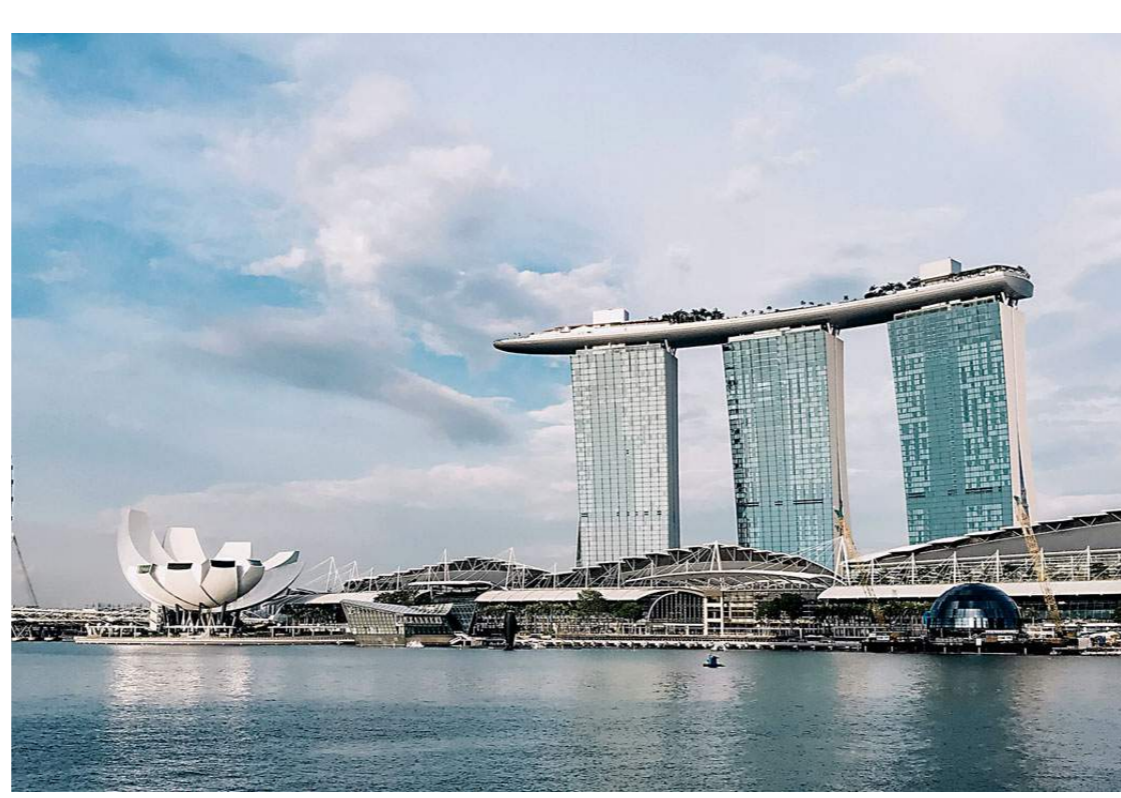
COUNTRIES GIVE A NOD TO COVAXIN

SINGAPORE TO LAUNCH VTL WITH INDIA



According to a recent announcement, Singapore intends to operate 6 designated flights daily from Chennai, Delhi & Mumbai under Vaccinated Travel Lane (VTL) facility with India from November 29. The Civil Aviation Authority of Singapore and Ministry of Civil Aviation, India agreed on the resumption of commercial passenger services with India. Since November 12, India has also started approving the vaccine certificates of Singapore, which means that fully vaccinated travelers from Singapore entering India will no longer need to undergo post-arrival tests, home quarantine, only self monitor for 14 days upon arrival is required.

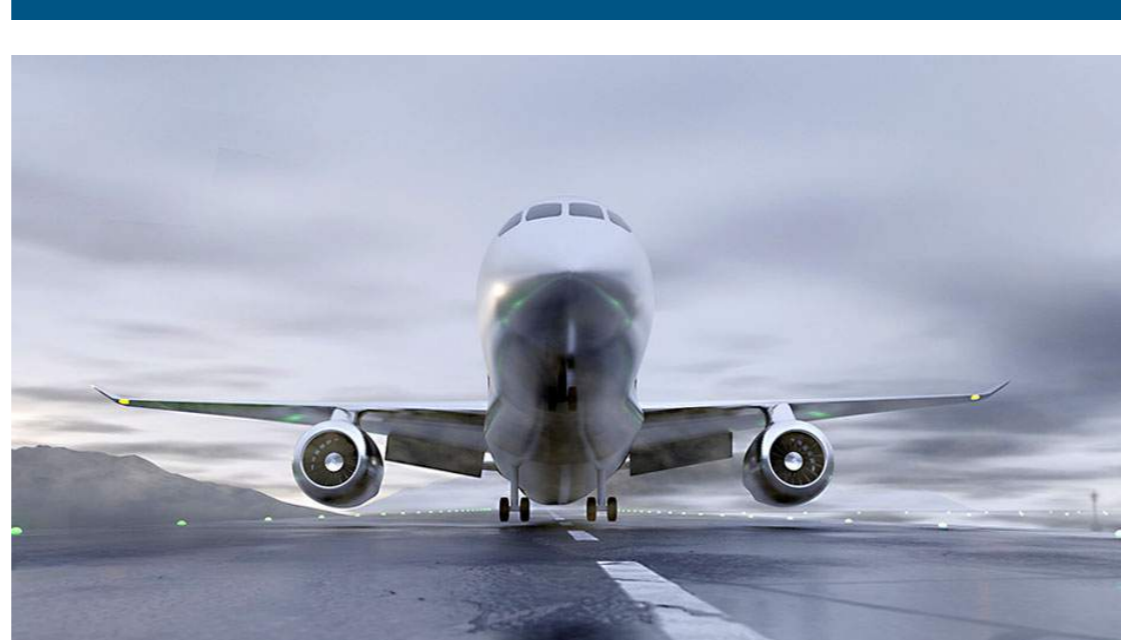
